Martin made nominations for life members. Motion to approve made by Garton and seconded by Briers. Motion passed.


Swan announced the nomination for AAAE Fellow. Swan moved to approve accept the nomination and Moore seconded the motion.

Murphy provided and handouts and discussed the proposed budget.


Osborne introduced and provided a handout of the proposed organizational realignment plans.




Swan moved to accept the reports. Seconded by Birkenholz. Motion passed.

It is hoped that this effort will provide assistance to the Executive Committee relative to planning and conducting organizational activities.

Treasurer's Report

As I begin my fifth year of service as Treasurer to the AAAE, I am optimistic about the long-term viability of our professional organization.

Membership is up, but this could be misleading. The total membership number was influenced primarily through the efforts of four institutions to recruit Student members. We had 30 new Student Members last year. Active Membership actually shrank by 4 members. Both the Eastern and Western Regions shrank by 10%. The Southern Region shrank by almost 1%. This will be the last year we report membership by four Regions. I hope to see growth in all three Regions next year. The complete Membership Report, as approved, is available on the website at: <http://aaaeonline.org>

Financially, the AAAE is sound. We have managed to improve our financial situation in the face of a very bleak economy. Two years ago, I estimated that we would finish the year with less than \$5,000 in reserve. We finished 2002 with \$17,837.76 in reserve. In the interim, we increased dues and membership. The 2003 Budget projects a reserve of \$7,905.27 for December 2003. We have maintained our support of The Council, CAST, and COSSA, and increased our annual expenditure for professional development. The budget, as approved, is available on the website at: <http://aaaeonline.org>

We have employed a CPA and will be finalizing the official status of our organization this spring. We have applied for, and hope to be granted Charitable (501C3) status by the IRS. In the event they deny that request, we will certainly be granted Tax Exempt (501C6) status. I will report the outcome of this effort to the profession as soon as details become available.

AAAE Southern Region Vice President's Report
Ed Osborne, University of Florida
Las Vegas – December 2002

The 2002 AAAE Southern Region Conference was held in Orlando on February 2-4 as a part of the Southern Association of Agricultural Scientists (SAAS) annual meeting. The University of Florida hosted the event, with 55 faculty and 26 graduate students attending. Major highlights included:

- Graduate student / faculty roundtables
- Joint session with Rural Sociology
- Business meetings and awards luncheon
- 24 papers presented in the refereed research conference
- 29 posters presented in the poster session
- Six professional development workshops on the following topics: *Getting Promoted and Tenured (two different sessions)*, *Distance Education Methods and Technology*, *Peer Evaluation of Teaching*, *Capstone Courses*, and *Student Motivation*
- Distinguished lecture presented by Dr. John Hillison on the topic “*Observations I Have Made, Lessons I Have Learned, and Questions I Would Like to Ask About My Profession*”
- Awards presented as follows: Distinguished Teaching – Bill Weeks; Distinguished Research – Rick Rudd; Outstanding Agricultural Educator – Walter Taylor; Outstanding Young Agricultural Educator – Kim Dooley; Outstanding Paper – Eddie Seagle and Maynard Iverson; First Runner-Up Paper – Kathleen Kelsey, Bill Weeks, and Rob Terry; Second Runner-Up Paper – Peter Bennett and University of Georgia faculty team; Outstanding Graduate Student Paper (tie for first) – Jackie Bruce, Texas A&M; Dwayne Cartmell, Oklahoma State; Outstanding Poster – Nick Place; First Runner-Up Poster – Ricky Telg and Tracy Irani
- Barbeque dinner and tour of the Citrus Research and Education Center, the world's largest citrus research center, located in nearby Lake Alfred.

Key decisions made during the business meeting included the establishment of a committee to begin developing a regional research agenda, establishment of the Journal of Southern Agricultural Education Research as an electronic journal, and a recommendation to post winning posters and papers on the AAAE website.

Mississippi State will host the 2003 Southern Region AAAE Conference in Mobile Alabama on February 1-4, and all Kentucky institutions will work together in hosting the 2004 conference in Tulsa. LSU will host the 2005 conference in Little Rock. The AAAE Southern Region Conference will continue to be held in conjunction with the SAAS

Conference, which serves as the regional meeting for faculty in most agricultural disciplines.

Using AAAE membership records as of November 2002, Ed Osborne is sending an invitation to join AAAE to all active faculty members in the Southern Region (as listed in the AAAE directory) who were not dues-paying AAAE members in 2002. These faulty members should receive their letters in December – just in time to respond before the new membership year begins January 1, 2003.

Rick Rudd is chairing a committee charged with developing a set of recommended policies for establishing an electronic journal for the Southern Region. This journal was electronically published under Rick's leadership as an outgrowth of the 2002 Southern Region conference. The committee will present its recommendations at the 2003 regional conference in Mobile.

Six faculty members from various institutions have agreed to lead subcommittees to outline research priorities for the AAAE Southern Region in the areas of extension education (Donna Graham), agricultural communication (Tracy Irani), agricultural leadership (Rick Rudd), teaching and learning in undergraduate and graduate academic programs (Kim Dooley), understanding the food and fiber system – Ag literacy (Jim Leising), and teacher education and school-based agricultural education (Bill Camp). The overall committee will bring its recommendations to the membership at the 2003 conference in Mobile.

2002 Western Region American Association for Agricultural Education Report

The Western Region, American Association for Agricultural Education (AAAE), held its annual conference at the WestCoast River Inn in Spokane, Washington from April 24 to 27 as part of the 21st Annual Western Region Agricultural Education Conference. The conference theme was "Mountainous Adventures in Agriculture." The conference included an orientation and welcome by the host state, six research sessions, and a poster session. Teacher educators, state supervisors and Region I NAAE teachers toured the 102 year-old Spokane Country Club, identifying the many ways a golf course can be used as a classroom laboratory. Stops along the course included pest management, environmental science, equipment, irrigation, landscape design and maintenance, and soils. Golf courses also provide opportunities for agriscience and supervised agricultural experience projects. John Mundt of the University of Idaho won the Western Region Putting Contest at the course. A wonderful dinner capped off an awesome afternoon at the club.

WRAAAE had two business meetings during the conference. An on-line committee was started to discuss alignment of our annual AAAE meeting and NAERC with ACTE. Discussion of AAAE regional realignment led to a resolution to permit Texas and Oklahoma teacher educators who are active in the Western Region to serve in Western Region offices and as regional representatives on national standing committees as long as they are not currently serving in a regional office or on a national committee representing the Southern Region AAAE.

The teachers, teacher educators, and state supervisors at the 2002 Western region Agricultural Education Conference decided to hold the 2004 conference in Honolulu, Hawaii. A planning group of Dr. Frank Walton (University of Hawaii, Manoa), Dr. Tom Dormody (New Mexico State University), Allan Sulser (Region I NAAE VP, Wasatch HS, Heber City, Utah), Dr. Mike Swan (Washington State University), Dr. Marty Frick, (Montana State University), Dr. Ed Franklin (University of Arizona), and Dan Hubert (Utah State University) has been charged with developing a conference agenda and conference budget to present at the 2003 Western Region Agricultural Education Conference in Portland, Oregon.

Western Region AAAE professional recognition went to Dr. Carl Reynolds (University of Wyoming), Distinguished Service; Dr. Robert Torres (New Mexico State University), Distinguished Teaching; and Dr. Carlos Rosencrans (New Mexico State University), Outstanding Young Member.

Notes from 12/14/2001 Meeting in New Orleans

1. Meeting called to order at 1:25 p.m. by Bill Weeks, PI Committee Chair.
2. Carol Conroy reported on the work of the AAAE Standards Writing Team. She presented us with seven recommendations. (see attached) Consensus was to drop the 4th recommendation and forward the other six to AAAE as recommendations. Consensus was to recommend to AAAE the adoption of the National Standards for Teacher Education in Agriculture.
3. Jeff Moss reported on the AAAE poster session. Eastern region will coordinate next year's session, followed by Southern, Western, and Central. Sub-Committee Reports

Membership and Recruitment. G. Briers reported that membership is not at its fullest potential within the regions. The committee discussed a possible joint membership with other professional organizations that would entice our peers to join AAAE. Those individuals whose primary professional discipline is not AAAE could receive a reduction in dues as an incentive to join AAAE. This offer would be reciprocated by other professional organizations to allow AAAE members the opportunity to join additional organizations. E. Osborne will check on this opportunity with Rural Sociology and Agricultural Communicators in Education.

The committee recommended Tim Murphy send each regional vice president and the regional AAAE professional development representative a list of institutions, dues-paying members, and copies of the dues form to send to potential AAAE members in their respective region. Motion passed.

Nominations. The committee recommended the past AAAE president (Jim Flowers) send a call for 2002 nominations to regional vice presidents prior to their regional meetings. This would allow discussion and recommendation of individuals for the openings. T. Hoover will share this recommendation with J. Flowers.

Awards. The Professional Development committee recommended that the eligibility criteria for the AAAE awards be reviewed for clarity. Motion passed. The awards sub-committee will share their findings at the 2002 Professional Development Committee meeting.

Pre-session/2001 NAERC. The research pre-session presented by R. Warmbrod was well received and the evaluations were overwhelmingly positive. This is my third and final year as the AAAE representative to the PAS Board of Directors. It has been a very fast three years but very enjoyable. My major contribution to the PAS Organization was conducting the college bowl competition at the National Conference.

The PAS Organization had a part-time Executive Director in California in 2000 when I arrived. Today, the organization still has a part-time Executive Director and a part-time administrative assistant, both of whom work for the National FFA. In my opinion, this was a very good step for the organization but not enough. The intent was to look at ways in which the National FFA can provide service to all college age students. I believe this to be a win, win situation for National PAS and the National FFA Organization. However, it is very difficult for the National PAS to get full time work out of part-time personnel. - ❑ Dr. Gruber spoke on a panel with Dr. Roger Beachy of the Danforth Center and Dr. Michael Fernandez of the Pew Biotechnology Initiative to a group attending the 10th Annual Soy Symposium.

LEADERSHIP DEVELOPMENT PROGRAM


