The American Association for Agricultural Education Ethical Standards for Publication

Agricultural Educators shall not publish manuscripts that have been published in any other published venue, with the exception of conference proceedings. If an author chooses to improve upon his/her work from a paper presented at a conference and resubmit the manuscript for publication to a peer-reviewed journal, he/she should clearly state in the cover letter to the editor that "this work has been previously presented at (specific conference) and is published in the proceedings".

For example, it is not acceptable to republish manuscripts that have been accepted for publication in the *Journal of Agricultural Education* or the *Journal of Southern Agricultural Education Research* in conference proceedings or any other peer-reviewed journal.

An example of an ethical procedure for publishing a manuscript is to submit it for presentation at a regional conference, if accepted, present and substantially improve upon the work, and then resubmit the manuscript with a note to the editor that "this work has been previously presented at (specific conference) and is published in the proceedings" to the *Journal of Agricultural Education* or the *Journal of Southern Agricultural Education Research*.
